- (4) Standard PHA A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) Troubled PHA A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) Qualified PHA A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

- The HATC is a community partner member of the Thurston County's Thurston Thrives' Housing Action Team that works to address key factors that impact affordable, adequate, and safe housing for all
- The HATC has entered into four new project-based voucher contracts for a total of 74 units of affordable housing
- The HATC has completed construction of Allen Orchard which consists of 24 twin-home units. Twelve of 24 units are set-aside for homeless families with children

Increase housing choices

- The HATC meets annually with the Multi-Family Crime Reduction Group which consists of local multi-family property managers
- Participants are encouraged at the time of initial eligibility and moves to locate units outside of concentrated poverty and into areas where there are job opportunities, transportation, quality schools, resources, and shopping
- The HATC entered into an inter-jurisdictional agreement with Thurston County and the City of Olympia to complete the Affirmatively Furthering Fair Housing Plan (AFFH) assessment. During the AFFH assessment, a multi-jurisdictional Fair Housing Group was formed to regularly meet and address issues related to the AFFH assessment including the lack of housing choice
- The HATC continues to make outreach efforts to locate new landlords through community involvement and networking

Improve community quality of life and economic vitality

- Maintain and grow the housing choice voucher family self-sufficiency (FSS) program. The HATC FSS program continued to be available to all HCV participants and had 48% of households earning an escrow
- Partnered with the Tumwater School District to provide services for twelve homeless families with children

- Undertook affirmative measures to ensure access to assisted housing regardless of race, color, religion, national origin, sex, gender identity, familial status, and disability:
